RURAL POLICING INSTITUTE TRAINING

The Federal Law Enforcement Training Center's (FLETC) Rural Policing Institute (RPI) will provide training to sworn law enforcement officers of Montana for the 2010 Joint Law Enforcement Convention. Training topics will include officer-involved shooting, officer health and fitness, preventing officer suicide, law enforcement reintegration after military service, active shooter, and use-of-force.

The RPI is a Congressionally-mandated initiative of the FLETC. Public Law 110-53 requires the RPI to evaluate the needs of law enforcement agencies and other emergency responders in rural areas; develop expert training programs based on identified needs; deliver training programs to rural law enforcement officers and other emergency response providers; and conduct outreach efforts to ensure rural agencies are aware of the training. TRAINING TERMS & CONDITIONS

In order to attend training, participants MUST present valid Law Enforcement Identification at registration. You MUST present your Law Enforcement ID to enter the training room. FLETC and MSPOA staff will be checking IDs.

FLETC-PAID LODGING for RURAL LAW ENFORCEMENT OFFICERS

In addition to providing training for the 2010 Convention, the Federal Law Enforcement Training Center's (FLETC) Rural Policing Institute (RPI) will pay for three nights of lodging for RURAL law enforcement officers whose agencies are located more than 50 miles from Helena, MT. Call the hotel and book a room in the Law Enforcement Convention block.

Almost all Law Enforcement Officers in Montana qualify as rural and will be eligible for free lodging. You **DO NOT** qualify for free lodging if you are from the following law enforcement agencies: Cascade County Sheriff's Office, Great Falls Police Department, Lewis and Clark County Sheriff's Office, Helena Police Department, Missoula County Sheriff's Office, Missoula Police Department, Yellowstone County Sheriff's Office, Billings Police Department, any Law Enforcement agency within 50 miles of Helena, or any State or Federal Law Enforcement agency.
