Any sheriff, deputy sheriff, or civilian support employee may submit nominations. Nominations must be typewritten or legibly printed. The nominator must explain in detail the circumstances that are to be considered by the selection committee. Include biographical information or other information to support the nomination or information of interest concerning the nominee.

Detention Officer of the Year

The person nominated shall be any Detention Employee of the Sheriff's Office whose performance has made a significant contribution to law enforcement and who has done more than what is normally expected in regular day to day duty.

Deputy of the Year

The person nominated shall be any Law Enforcement Officer of the Sheriff's Office whose performance has made a significant contribution to law enforcement and who has done more than what is normally expected in regular day to day duty.

Chaplain of the Year

This award recognizes a chaplain who has made outstanding contributions to law enforcement and his/her agency or who has demonstrated conspicuous excellence in the performance of his/her duties.

Distinguished Career Award

The person nominated shall be any employee of a Sheriff's Office whose performance has made significant contributions to law enforcement over the course of an entire career.

Purple Heart

The person nominated shall be any employee of a Sheriff's Office. The Purple Heart is given for having sustained personal injury, in the intelligent performance of his/her law enforcement duty, inflicted by an assailant with a dangerous weapon.

Medal of Merit

The Medal of Merit is given to a law enforcement officer and/or a civilian for a contribution to his/her community and to the Field of Law Enforcement and Criminal Justice.

Awards recipients are determined by the MSPOA Public and Community Relations Committee members after thoughtful consideration of each award's purpose and criteria and the qualification and outstanding achievements of each nominee.

Application Deadline is April 15th, 2019.

* The MSPOA Public and Community Relations Committee has gone through the process of evaluating the MSPOA Awards distributed and the process by which award recipients are determined. In the analysis, the members of the committee decided to temporarily suspend the Life Saver Award as any single life is not more important than any other life. The committee will continue to discuss the most appropriate way to honor those deputies who took life saving measures outside the course of their regular duties while also adhering to safety policies and procedures.

MSPOA Award Process

- Completed and signed award nomination forms, narratives and photos must be submitted NO LATER than April, 15, 2019.
- MSPOA Public and Community Relations Committee Members will evaluate each nomination and determine the award recipients in each award category. There may not be an award recipient in ALL categories, EVERY year. The committee has the discretion to choose the award winners based on the purpose and criteria for each award and the qualifications and outstanding achievements of each nominee.
- By May 15, the Chair of the Public and Community Relations Committee will contact all award NOMINATORS and let them know the status of the application he/she submitted (both those in which there was a successful award recipient chosen and those in which the nominee was not chosen to receive the award).
- Once the NOMINATOR has been informed that the person he/she nominated is the award recipient, MSPOA Staff will coordinate with the NOMINATOR and/or the NOMINEE to make arrangements for attendance at the Annual MSPOA Awards Banquet.
- MSPOA invites award recipients and their family and friends to attend the banquet.
- MSPOA pays for the following: banquet tickets for the nominator, award recipient and the immediate family of the award recipient (spouse and kids or parents) as well as ONE hotel room for the award winner.
- Additional banquet tickets can be purchased for family, friends and colleagues who would like to attend the banquet. Tickets are typically about \$35.
- The 2019 Annual Banquet will take place in Missoula, Montana on Thursday, June 20, 2019.
