Legal Based Jail Training

Presented by Joshua Arnold, National Institute for Jail Operations

The purpose of this all-day workshop is to educate corrections professionals on critical legal and liability issues in jails. Training topics will include legal liability, gangs, transgender, grievances, religion, court testimony, use of force and report writing. NIJO provides legal-based training and resources to assist correctional administrators to operate constitutionally safe and defensible facilities.

Joshua Arnold has a wealth of knowledge and extensive experience in corrections, having worked in the field for over 23 years. In 2020, he retired as a Captain at the Pima County Sheriff's Department (AZ). While working with NIJO, Joshua has been the lead inspector for several facility inspections seeking NIJO Accreditation. He has trained on topics of code of conduct, ethics, leadership, use of force, searches, duty to protect and classification at local and regional NIJO seminars and at JAILCON Corrections Training Conferences. Joshua is also a popular instructor in NIJO's online training platform, DACOTA. Mr. Arnold is a National Certified Corrections Executive and a graduate of the National Jail Leadership Command Academy and Northwest University's Police Staff and Command Academy.
