# Additional Training Course Information and Presenter Biographies

## **NIJO Detention**

#### **Conflict Management Techniques (CMT) Training Sessions (4hrs)**

The primary reason jails are involved in litigation remains due to sustained injuries from physical altercations. What if lawsuits surrounding physical altercations and conflict could be reduced? What if officers were more skilled to interact with mentally ill and suicidal inmates? What if supervisors could reduce turnover by effectively by reducing staff conflict through proven techniques? CMT hands-on training provides real life examples and practice scenarios for attendees to work through as they gain knowledge on not only the causes of conflict, but the proven tactics that will effectively manage conflict within their facility. It supersedes current de-escalation training with a far more intensive and practical application than anything else provided to corrections officials.

#### **Emergency Preparedness (2hrs)**

This class will discuss the 4 stages of Emergency Management and provide examples of out of the ordinary hazards/situations/dangerous situations that happen in the jail setting.

#### **Inmate Classification (2hrs)**

Inmate Classification is the ongoing process of collecting and evaluating information about each inmate to determine the inmate's risk and need for appropriate housing and programming assignments. Jail classification should be developed to uniformly place inmates in the lowest security level consistent with the safety of staff, inmates, and the public. This training will focus on failure to protect claims and what jail officials need to know to determine the adequacy of their current classification system.

#### Aaron M. Dawson



Aaron Dawson has made a lifestyle of investing in others regardless of the field. His background in educations, ministry, and corrections has provided a variety of experiences and interactions that aid in his instruction. He served as the Warden of the Morgan County Correctional Facility in Decatur, Alabama. He was part of the founding board of the Alabama Jail Administrators' Council, created to bring professional level training to Jails in Alabama. Aaron instructs for the National Institute of Jail Operations, the Alabama Basic Corrections Academy, as well as the Morgan County Basic Jail Academy. Aaron focuses on interpersonal relationships and interaction, leadership, communications, personal growth, and the fundamentals of charactered success. He is married, and he and his wife Kori have four sons. He enjoys teaching, woodworking,

faming, writing, and is a self-proclaimed bibliophile.

## Joppa Leadership

#### **MASCOT Leadership Training**

MASCOT Leadership: Organizational/Individual Identity – Who do you Represent? In law enforcement, individuals are often promoted to supervisory positions before receiving training to serve in those positions effectively. This has ended in catastrophic failure or the proverbial sink-or-swim situation for many first-line supervisors. These first-line leadership failures can have a high price tag for law enforcement agencies. The MASCOT LEADER will find foundational success principles in their agency's mission, values, policies, and procedures. Using the MASCOT memonic, attendees will embark on visible and memorable perspectives of these usable principles. The MASCOT Leadership model is a valuable resource for officers seeking to become first-line supervisors or those already in the role but needing to heighten their leadership acumen. Moreover, there is a theme throughout the training stressing the officers' need to recognize that they are direct representatives, like a MASCOT, of their organization when in uniform.

## Instructor

#### William G. Thompson Jr.



William G. Thompson Jr. (Jerry) is a retired 31-year law enforcement veteran, having served with the Ohio State Highway Patrol. Jerry started as a cadet dispatcher and ended up as the Northeast Ohio LCS Unit Commander as an Ohio Peace Officers Training Instructor since 1986, providing instruction throughout Ohio. In addition, served as a schoolteacher at the Mahoning County Career Technical Center, administering the Law Enforcement and Fire Safety Programs. Currently, with FBI-LEEDA, Jerry provides instruction in various topics focused on leadership. FBI-LEEDA has honored Jerry with the designation of Master Instructor because of his sustained in-class instruction.

Jerry, a continuous public servant, was raised in the inner-city of Youngstown, Ohio, in the early sixties and seventies by devout Christian parents who stressed hard work, common sense, personal responsibility, and respect for others. This has played heavily in his success in life and within each organization he has served. Moreover, Jerry is an Arbinger Institute's – Developing and Implementing an Outward Mindset program trainer.

## Protecting the Guardian

#### Hitting Rock Bottom Is An Opportunity To Re-Build Yourself

This session focuses on mental health wellness, suicide prevention, statistics of suicide and mental health illness, surviving the job, retirement and Mr. DiBona's personal story of my mental health issues and suicide attempt. Attendees will leave the session with an understanding that mental health illness can happen to anyone, be able to demonstrate how one can still thrive while living with mental health illness, help reduce the stigma surrounding mental health illness, and have the tools to develop a mental health wellness plan.

#### Instructor Mark DiBona (Ret. Sgt.)



Mark DiBona was born and raised in Boston Massachusetts. In 1985, he began his Law Enforcement career with the Braintree Police Department and later transferred to the Amtrak Police Department, Boston District.

In 1993, Mark moved to Florida and continued his career with the Avon Park Police Department and the Seminole County Sheriff's Office, 19 years as a Patrol Sergeant. After 25 years with S.C.S.O. and 33 years of Law Enforcement experience, Mark retired in 2019, he was also Police Academy Instructor.

He is a Co-founder of Protecting The Guardian a Technical Advisor and Law Enforcement Mental Health Liaison with In The Line of Duty Video's. Board Member and Law Enforcement Mental Health Liaison with Southeastern Homicide Investigators Association. Technical Advisor for PTSD 911 documentary movie. A Member of International Law Enforcement Educators and Trainers. Also, a Motivational Speaker with Bravo748 Speakers Bureau.

Throughout his Law Enforcement career, Mark has held several positions and assignments, to include Field Training Officer, Street Crimes Unit, Traffic D.U.I. Unit, Peer Support Unit, Critical Incident Stress Management Team, Public Information Officer and In-Service Training Instructor.

Mark is an advocate for First Responder suicide prevention, mental health education and wellness. During his career, Mark developed mental health issues and a suicide attempt. He is very open speaking about these issues and his wellness.

#### Law Enforcement, Leadership, Success

#### **Sheriff Mark Lamb**



Sheriff Mark Lamb was born and raised in Hawaii, but his original roots are firmly planted in Chandler, AZ where he went to Junior High and graduated from Chandler High School in 1990. After owning several businesses and moving back to his hometown of Chandler, he became a police officer for the Salt River Pima Maricopa Indian Reservation.

During Academy, Lamb was valedictorian of his Academy class. Then, Lamb went on to become Rookie of the year as an officer. In the subsequent years, Lamb was named Officer of the year and then Detective of the year. Lamb served on the SWAT Team and

was a very successful gang and drug detective who, alongside federal and local partners, took down some of the most dangerous gangs operating off of the reservation.

Lamb later moved to the Pinal County Sheriff's Office as a deputy. His love for his country, the constitution, and the people of Arizona compelled him to run for Sheriff, which he did successfully in 2016, and he loves every minute of it.

During his first term, Sheriff Lamb has been able to do all he set out to do and more, due to cooperation with the other County leaders, command staff, and fantastic deputies. He is a proven advocate and proud supporter of our Constitution and will continue to publicly defend it.

He and his wife, along with their five children, have made San Tan Valley home for the past 13 years. As Sheriff, he focuses a lot of time on youths in the community and supports activities that help them grow into dedicated, successful adults.
